

SEED DIRECTORY 2024 Crop Year



Long summer days, cool nights and a large, available land base in isolated geographic areas have resulted in Alberta seed that is characterized by increased vigor, high quality, high yields, lower disease and pest problems.

To maintinan low disease levels in seed for export customers and Alberta farmers, seed potatoes are grown under a limited generation system, whereby seed potatoes remain in a certification system for a maximum of 7 consecutive field-grown generations. Alberta growers are not in practice limited by this system, as they almost exclusively sell seed that is, at most, the 4th field-grown generation.

Alberta seed producers are regulated under the Canadian Seeds Act and are inspected and certified by the Canadian Food Inspection Agency. Canada's strict national program ensures only seed potatoes meeting the requirements receive certification and are marketed domestically and internationally. Each growing season includes two field inspections, as well as shipping inspections on each seed lot. Established seed growers also submit samples for the post-harvest test grow-out, inspected by CFIA inspectors, as well as, additional testing to ensure Alberta seed meets the high standards it has become known for.

Between the PGA, government and industry, there is a demonstrated commitment to improving the genetics of potato varieties grown in Alberta. Our province is one of the few in Canada with privatized high generation lab and greenhouse production. All laboratories operate under the guidelines of the Canadian Seed Act and are CFIA approved and inspected. On-farm greenhouses receive potato plantlets from the tissue culture bank operated by the provincial government.

ALBERTA SEED POTATO PROGRAM

The Canadian Food Inspection Agency (CFIA) provides certification of seed potatoes under the authority of Part II of the Regulations to the Seeds Act.

At present, Alberta Agriculture & Irrigation serves as a source of disease-free stock plants for the private tissue culture labs located throughout the province. The Repository is home to over 300 public and private varieties.

Aphid populations tend to be low in comparison with other areas in North America hence virus levels in Alberta seed are normally low. To further ensure high quality seed potatoes are produced, growers have agreed to voluntary post-harvest by visual inspection and/or lab testing.

STANDARDS AND REQUIREMENTS FOR THE GROWING CROP

Canada operates under a single federally run seed certification agency applicable to all provinces. Seed classes within the classification system are based on both generation and disease level and the generation depends entirely on the number of years planted in the field. There is zero tolerance for *Clavibacter michiganensis* subsp. *sepedonicus*, Potato Spindle Tuber Virus and the tobacco veinal necrosis strain of Potato Virus Y (PVY^N), as shown in Table 1. Testing for viral and bacterial disease is done by CFIA accredited laboratories. All seed lots designated for export have been PCN tested.


